



Instructions for abstract authors

The objectives of the Health Services Research and Pharmacy Practice (HSRPP) Conference are to identify and disseminate research that informs policy and practice development along with providing an encouraging environment. The conference enables pharmacy practice researchers to share ideas about their research and best practice with their peers. Particular emphasis is placed on disseminating the work of early career pharmacy practice researchers. The conference has a global reach and its papers are published in the [International Journal of Pharmacy Practice](#).

1. Topics

Submitted abstracts should relate to original, unpublished work contributing to the understanding, development or evaluation of health services or pharmacy practice research. Papers on any aspect of pharmacy practice or health services research relevant to medicines or pharmacy are invited. We are keen to include a broad range of subject areas and would particularly welcome papers addressing the following subjects:

- Cost effectiveness
- Health policy
- Health promotion
- Interface issues
- Measures of outcomes
- Non-medical prescribing
- Pharmacoepidemiology
- Pharmacy practice research
- Drug utilisation studies
- Health services policy research
- Medicines usage
- Multi-disciplinary teams
- Prescribing issues
- Patient perspectives
- Quality issues

Abstracts are welcome from qualitative and quantitative research projects. Works in-progress can be submitted provided there is a sufficient amount of results suitable for publishing. Systematic review projects are also eligible for submission.

2. Abstract submission process

You are asked to follow the guidelines when submitting an abstract. Abstracts which do not adhere to the formatting guidelines below will **NOT** be considered.

All abstracts **MUST** be submitted via the electronic [submission form](#) on the HSRPP website by **17:00 on Friday 9th October 2015**.

- Please note that **two** copies of your abstract are required – one full version and one to be **anonymised** (where all names, place of work and any identifying information **MUST** be removed from the abstract).



- Your abstract file names should follow the following format:
 - Full abstract version - Surname Initial.doc e.g. Smith J
 - Anonymised - ANON Surname Initial.doc e.g. ANON Smith J

2.1 Abstract format

- Abstracts **MUST** be between 350 and 500 words, or a maximum of 350 words if a table or figure is included (the word count does not include the title, authors' details or references). Please note that abstracts which require revision following review must also adhere to the word count.
- Abstracts must be submitted in Microsoft Word.
- Abstracts must be typed in Times New Roman font 11 in a single column.
- Tables and references should be typed in Times New Roman font 9.
- Figures should be black and white and capable of being reproduced clearly when reduced to 55mm wide. Figures should also be supplied with a high resolution image file in a popular format, such as TIFF or JPEG.
- Each abstract should have no more than two references.

2.2 Abstract content and structure

Your abstract **must** include the headings below. These are used to assist the adjudication process and will be removed at publication stage. Please, therefore, ensure your abstracts make sense without them.

- Each individual can present one paper only. However, you may be listed as co-author on any number of abstracts.
- Please list all authors' names under the title. Type all names in lower case, initials followed by family name, for example: J. McElnay, C. Hughes, G. Crealey.
- Where there is more than one author, the presenting author should be named as first author. The names of all authors will appear with the abstract.
- Provide name of institution and email address of corresponding author in lower case. Do not include the full work address.

2.3 Abstract style

Abstracts should be in the style of the International Journal of Pharmacy Practice, as follows:

- Do not underline or use italics, except as required by usual convention.
- Do not use lines on tables except on the top and bottom.



- References should be cited in the text as superscript numbers in the Vancouver style e.g. [3]

3. Abstract Review Process

Abstracts will be sent to Adjudicating Committee members who will meet in **November 2015** to consider the abstracts. They will use the [judging criteria](#) set out on the website. Accepted abstracts will be assigned to an appropriate session within the conference on the basis of subject and number of abstracts received.

- Receipt of abstracts will be confirmed by email and authors will receive notification of the committee's decision by **w/c 23rd November 2015**.
- Any amendments to your abstract must be completed and returned by **17:00 on Friday 11th December 2015**.
- Anyone who has an abstract accepted **MUST** register for the conference by **19th February 2016** (closing date for the early bird registration). If you do not register by this date, the relevant abstract(s) will be removed from the conference programme and the IJPP supplement.

4. Presentation format of accepted abstracts

Accepted abstracts may be selected for oral presentations or posters. You will be required to indicate on the Abstract Submission Form if you would accept oral or poster or either type of presentation.

- Oral presentations will consist of a 15-minute presentation followed by a 10 minute discussion.
- There will be a poster discussion forum, where poster presenters will stand by their posters and will be asked to speak for two minutes about the content of their poster. Posters will be displayed throughout the two days of the conference.

Your abstract MUST follow the above guidelines otherwise it will NOT be accepted.

The abstract must be between 350-500 words (excluding Title, author's details and references)

References (font: Times New Roman, size: 9 as indicated below)
